"RULES AND PROCEDURE FOR THE SELECTION OF LAW SOCIETY"

1. ELIGIBILITY: Following students are eligible:

- a. B.A-LL.B program Students of 2nd, 3rd, 4th and 5th Year only.
- b. LLB program Students of 2nd and 3rd Year only.
- 2. CRITERIA: The selection shall take place as per the following criterion

3. PROCEDURE:

- (i) Interested candidates are required to submit a duly filled form, provided in the Annexure-2 to this notification, with Mr. Hakim Yasir Abbas, Teacher-In-Charge of the Law Society, School of Law, University of Kashmir, by or before 3rd of May, 2024 (Friday). Following documents must be attached with the form.
 - (a) Copies of all transcripts (marks-sheets) upto the latest semester for which the results have been declared.

[Students who don't have the official copies of such transcripts can also submit a print out of the marks as reflected on the official website of the University under the "Examination" section. However, it must be noted that the same will be verified by the Selection Committee from the competent authority].

- (b) Copy of the student's ID Card.
- (c) Copy of an updated C.V.
- (d) Copies of all achievement certificates (including internships, experience certificates and volunteer work), mentioned in the C.V.
- (e) Copies of all publications (published in the Law Journals, Law Reviews, and Newspapers etc.)
- (ii) All applicants will have to appear for an interview before a Selection Committee duly constituted by the Head and Dean, School of Law, University of Kashmir, being the Patron of the Society.
- (iii) The final selection list shall be made by the Head and Dean, School of Law, University of Kashmir, on the recommendations of the Selection Committee.
