Guidelines for Examination

The students of the School of Law, University of Kashmir and affiliated law colleges for the end semester examinations of BA.L.L.B 1st, 3rd, 5th, 7th and 8th semesters (Regular/Backlogs) and LL.B 1st, 3rd and 4th semesters (Regular/Backlog) and BA.LL.B 9th, 10th and LL.B 5th, 6th (supplementary examinations) shall be required to follow the below mentioned guidelines in letter and spirit in order to ensure smooth conduct of examinations.

1. Only those eligible students shall be allowed to appear in online examination of the aforesaid semesters who have registered their email addresses and enrolments with the School of Law through the links notified earlier.
2. Examination link shall be shared to the students in the inboxes of their registered email addresses on the scheduled date/s, one hour before the commencement of the examination. During this one hour gap, students are directed to ensure that they have received the examination link in the inboxes of their registered email addresses. No claim pertaining to examination link shall be entertained afterwards.
3. The online examination is protected by the password and the same shall be shared to the students on departmental website one minute before examination the commencement of examination.
4. No response shall be accepted from the students after the due time.
5. Responses only from registered email addresses and enrolments will be accepted.
6. Those students who have not registered their email addresses are again asked to do that by 10 pm today i.e.17-06-2021.
7. Students facing any issue/s particularly pertaining to examination link shall contact their respective teacher incharge/s on their cell numbers as reflected in the below mentioned schedule, half an hour before the commencement of examination.
