- 5. The candidate shall be required to be well versed with pre-trial proceedings, like counselling techniques, interviewing and lawyering methods, preparation of suits, notices, writs, memorandum of appeals, affidavits, undertakings, applications execution proceedings, FIRs, remands, challans, police dairy, techniques of client-lawyer interactions, plaints, written statements, objections, examination of witnesses including cross-examination, re- examination, writs, injunctions, judgments etc.
