

Preface

This document pertains to the operations of the Law Society (hereinafter to be referred as the "Society") within the School of Law, University of Kashmir (hereinafter to be referred as the "University"). The Society was established for the Academic Session 2022-2023, with its members appointed on the 14th of July, 2022. Upon the culmination of its designated term, the Society's Executive Council was officially dissolved on the 4th of July, 2023. The contents of this document encompass detailed information concerning the structure, functionality, and the array of events and programs orchestrated by the Society. During its inaugural assembly, the Society comprised a total of 16 (sixteen) individuals, who held roles as both Executive and Working Members. However, upon its dissolution, the Society's ranks had diminished to a complement of 10 (ten) such dedicated members.

Delving into its historical origins, the Society emerged as a vision cherished by the founding minds of the School of Law, then recognized as the Faculty of Law within the University. The inception of this venerable institution traces back to the late 1970s, initiated by the patrons of the Department. However, due to circumstantial exigencies, it lay dormant for a considerable duration. Nonetheless, in April of 2008, the Society orchestrated a grand charitable campaign named "Ehsas," dedicated to assisting individuals afflicted with leprosy. A significant turning point materialized in April 2011, when the Society underwent a renaissance, assuming a rejuvenated form. The bedrock principle that underpins the Law Society revolves around the notion of valuing and embracing a select few pertinent endeavours, rather than burdening humanity with an excess of frivolous pursuits. This ethos guided the Society in organizing a spectrum of events encompassing debates, quizzes, and competitions, spanning both legal and non-legal domains. A pinnacle of the Society's journey was reached in 2018, marked by the successful hosting of a National Moot Court Competition, which solidified its reputation and impact in the academic and legal spheres.

The Society is established under, and discharges its functions according to, the **Policy of the Law Society (2017),** having the recognition of the administration of the University as a university-level body.

The Society is under the stewardship of the distinguished Head and Dean of the School of Law, who serves as the Patron. The Head and Dean also assumes leadership of the Administrative Council of the Society. Assisting in this capacity is the Teacher-in-Charge of the Society, a faculty member of the School of Law, who regularly aids in fulfilling the responsibilities inherent to the role of the Patron. At the heart of the Society's framework lies the Executive Council, serving as its principal organ. This council orchestrates a myriad of events and programs, undertaking a range of duties as stipulated by the aforementioned policy.

As on 30th December, 2023 the Society organized, or facilitated, a total of 24 distinguished occasions, encompassing a trilogy of grand events alongside an array of smaller engagements. Among these, a diverse array of activities such as quizzes, debates, seminars, workshops, and sporting events graced the Society's roster. A comprehensive record of all these noteworthy events is meticulously documented below.

They can also learn the nuances of legal research, a comprehensive understanding of factual situations, and how to present those situations persuasively.

Although most law schools provide some rudimentary instruction in moot court, this instruction is typically superficial and insufficient to master the challenging art of mooting. The aforementioned workshop, therefore, sought to close this gap and offered thorough instruction in comprehending the mooting procedure, composing memorials, and providing helpful professional counsel to succeed in mooting.

She further said that collaboration between law enforcement agencies, technology companies, academia and civil society is crucial to develop effective strategies for preventing and combating cybercrime against women.

Sharing his observations and concerns pertaining to cybercrimes, Dean Academic Affairs, KU, Prof Farooq Ahmad Masoodi, stressed the need for awareness campaigns and digital literacy initiatives that are essential to educate women about online safety and reporting mechanisms. "The anonymity afforded by the online environment emboldens offenders, making it challenging to track and prosecute them," he said, adding that as responsible members of the society, we need to draw meaningful and effective lines for the development of societies with zero tolerance for cybercrimes.

Founder, Cyber-Peace Foundation, Vineet Kuma, said that cybercrime against women is a specific aspect of this broad challenge, encompassing various forms of online harassment, abuse and exploitation targeting women. "Addressing cybercrime against women requires a multi-faceted approach that combines legal, technological and societal efforts to create a safer digital environment for all," he said, adding that under-reporting is the biggest challenge right now, as people do not come forward to register complaints.

Outlining the aims and objectives of the seminar, Head and Dean, School of Law, UoK, Prof Mohammad Hussain said that strict legal frameworks, coupled with swift and efficient law enforcement responses, can act as deterrents and provide recourse for victims. "Empowering women through education, support networks and digital literacy programmes is also key to foster resilience and reduce the impact of cybercrime in the online spaces," Prof Hussain added.
