

Four Units- Four CAs of 5 marks each
Three Units- Three CAs of 7+7+6 marks each
Two Units- Two CAs of 10 marks each.

Resolutions:

The minutes of preceding Board of Studies meeting held on September 1. 14, 2021 hereby stand ratified.

It was resolved that for allotment and evaluation of LL.M projects, the 2. following scheme shall be followed:

The allotment of project topics and evaluation of projects, to be assigned by Course Coordinator, through Teacher In-charge concerned

Evaluation by Internal Expert. 2.

Constitution of Seminar/ Project Committee. 3.

Constitution of Board of Examiners (BoE) for this 4. purpose.

- 5. The composition of BoE shall comprise of three members viz; Dean of School or his/her Nominee / LL.M. Course Coordinator / Teacher In-charge.
- 3. It shall mean 'Essay on Relevant Contemporary theme'
- 4. It was resolved that since LL.M is a research degree, the entrance examination for admission to LLM program shall be conducted by Dean Research, University of Kashmir instead of Director of Admissions and Competitive Examinations, UOK. In this regard, a detailed proposal may be submitted to competent authority of varsity viz; VC/DAA.
- 5. It was resolved that intake capacity of 40 seats for LLM program shall be retained and no reduction of LLM intake capacity shall be made.
- 6. It was resolved that in Core paper/course, each students shall appear in Continuous Internal Assessment for each of its Units. Maximum Marks shall be cumulative 20 points/ total no. of CAs. The scheme of continuous assessment shall comprise of the following pattern:

Four Units- Four CAs of 5 marks each. Three Units- Three CAs of 7+7+6 marks each. Two Units- Two CAs of 10 marks each.

- 7. It was resolved that a Board of Examiners (BoE) shall be constituted for this purpose. The students shall be requested to submit research topics within the stipulated date prescribed by the department, immediately after the examination of the semester, in the office of the Dean, School of Law. DRC concerned shall take call on the topics before allotting topics to the students.
- 8. To make it a serious assessment exercise, it shall be mandatory for each of LL.M. Scholar that before appearing in Teaching Practice he/she shall ensure the following:

a. Apply for grant of permission from the Board of Examiners;

- b. Preparation of Teaching Material on assigned topic from pool of a Course Papers of Odd/Even semesters and submit the same for approval before the Board of Examiners;
- c. Pass Scrutiny Test of Teaching Literature by facing clarification/queries from Board of Examiners
- d. Teaching practice duration shall consist of 10 lecture classes, excluding holidays;

- e. During Teaching Practice, the concerned Teacher-Incharge shall remain present/attend the practice of the concerned LL.M Scholar;
- f. Practice of Student Feedback during Teaching Practice shall stand cancelled/repealed;
- g. The teaching Practice shall commence in 4th Semester;
- h. Revised Evaluation Format for 250 marks to be drafted
- 9. It has been strictly resolved that once the students are admitted to regular LLM program of full time duration, physical attendance of the student is mandatory. Further, a student admitted in the LLM program shall not engage in any sort of activity/conduct/practice/occupation/vocation.
- 10. Program course structure of LL.M. 2 year program to be retained.
- 11.It was resolved that OE subjects shall be continued for determination of promotion.
- 12. Compulsory minimum attendance of LLM students shall be implemented fully.
- 13. Their shall be a continuous Curriculum Review Committee and Sub-Committee for a term of two year period to review the curriculum design.
- 14. Explore the possibilities of introduction of LL.M-PhD Integrated Degree programme and submit a proposal before competent authority.
- 15. The students shall be directed to do 60-70 % of empirical work.
- 16. The suggestion from the External and Internal-Experts shall be accepted and incorporated.
